From the President

I just wanted to update you on a few matters relating to the club going forward.

Future Meetings

With the current restrictions imposed by the authorities and the high risk of being infected, my and your committee's priority to you the members is to do everything we can to protect you from this virus.

Hence, we have made the decision to postpone any future meetings indefinitely and revisit this decision in August. We will be monitoring this situation on a daily basis and in the case that a change takes place we will let you know.

We don't feel good in making this decision, but it is the right one to make and I know that you will be understanding of this.

Premises

As previously reported the Hunters Hill Club indicated to us that we would be unlikely to return to the premises on completion of the renovation work. They cited several reasons revolving around the leasing arrangements with the new caterers.

A letter was sent to the Chairman and Secretary of the club stating our case as to why we should be using the HH Club as our meeting venue and the historical significance the two clubs have had in the past 20 years.

Following this, a meeting was arranged and Dean Letcher and I met with the Chairman and Manager of the Club last and week and discussed a number of issues. They include our meeting start and finish time, the cost, which is likely to increase significantly, storage space, a functional audio/visual system and a place to hang our Honour Boards.

As a result, the Club's response was a lot more favourable to our returning than we expected, given a few details still need to be resolved. We are quietly confident that we can reach an agreement.

Discussions are still underway, and a result is likely to be known next week.

Functions

Unfortunately, all functions currently planned will need to be cancelled. Of course any future ones planned will not be taking place until restrictions on social spacing and the Coronavirus is brought under control.

Jill Regnis is currently negotiating with the provider of the Harrington trip for all money paid by members be refunded or a credit be given to go on a later date. Jill will be contact with everyone involved as to what is to take place.

For other functions where deposits have been taken, these will be refunded by the club.

That is all for now. I will keep in touch with you via the Newsletter as the need arises.

Please look after yourselves, keep healthy and we will see you when our next meeting takes place if not before.

When he finished high school and had to decide what he was going to do as a career, he knew the last thing he was going to be was an Electrical Engineer. He hated Chemistry and Physics was not his favourite subject. He was good in maths and studied ***** honours maths for the HS certificate, but later had to drop this to concentrate on Physics and Chemistry. Well he didn't do so well in Chemistry but did well in maths. He has 3 children, 2 daughters and a son and 4 grandchildren. He has a number of hobbies namely called, Nicholas, Oliver, Luca and Anastacia. He loves being involved with sport, playing with the kids, where he can these days and going to watch them play. On most Saturdays, some of his day is taken up doing just that. He is the Age Manager U8-9 for the local soccer club, All Saints Hunters Hill Soccer Club. He also coaches his grandson's soccer team. He professes not to live a very exciting life really. His involvement with the soccer club keeps him busy from late January to the start of April, as does being a member of Probus and participating on the committee. Other than that, his wife Fay keeps him busy with household things, the usual being cleaning the pool and mowing the lawn etc, although he is slowly outsourcing this. We were excited because we were about to experience our first ride on Sydney's Light Rail – the new tram to Kensington. We then learned that the line to Kensington was still under construction and the tram terminated at Randwick.

When we approached the tram stop we noticed that the people on the tram were getting off. Then the signs on the tram started to flash *"Not in Service"*. From enquiries we learned that there had been an accident on the tram route and the service was temporarily suspended. So we did what all sensible people do, found a coffee shop for a cuppa.

After our coffee, we went back to the tram which was now back in service. We all climbed aboard and off we went. The journey up George Street was slow with many stops. However at the top of George we stopped for about 5/7 minutes. It seemed as if the traffic control was just not up to handling trams. But eventually we moved off. However, after a very short distance, at Central Station, we were then told that our service was terminating and would we please leave the tram, which, of course, we did.

On the platform we were then informed that another tram would be along in about 2 minutes. The rest of the journey from Central to Randwick was surprisingly without incident.

None of us were familiar with Randwick so we explored the main street and found a very nice old sandstone restaurant where we enjoyed a good lunch.

Once back on the tram the return journey was quite fast, uneventful and pleasant. Compared with the journey out to Randwick, the return was almost dull!

The infrastructure, stations, lines, signs and the tram itself are all exceedingly good (world class) but the operating systems seem to require a great deal of improvement to stop the trams from being "temperamental".

President's Report to the 44th Annual General Meeting

I start my report by thanking myself for being here this year. As you may recall I was unable to make it last year and probably set a Probus record for not turning up to my own investiture as President.

My aims as the new President were somewhat selfish, to enjoy myself, attend as many activities as I could and bring some lightheartedness and levity to the proceedings. Did I achieve any of those, certainly the first two, the last; I'll let you be the judge. I started the year with 3 new committee members, Carolyn Jolly, Barbara Banner and Judith Dunstan and was missing a Vice President. However, I think as your management committee we all worked well together.

Carolyn Jolly as Secretary fulfilled the requirements of her role extremely competently and without fuss. However, I must have overburdened her as she finished her year in office undergoing serious back surgery. Judith Dunstan, in her Treasurer role, suffered midterm with some family issues putting undue stress on her such that she resigned from the committee. Fortunately, Jim Likidis stepped in to fill the breach for the remainder of the year. Barbara Banner's took on Activities.. She was, initially, I think, somewhat wary of taking it on but as you have seen she has thrived in the role and has organised some great activities and encouraged others to help out. Carol Pelham, what can I say? She keeps on keeping on. Never short of interesting speakers to keep us entertained. Long may she continue. Ashlyn, well, I'm biased but think she did a great job checking up on those not enjoying good health, sending get well cards and making visits. where appropriate. Gordon Sanson started the year as Membership officer but succumbed to a reaction from medication such that he had to discontinue. Peter Kelly helped out until Kevin Manie took on the role. Jim Likidis, a late entrant, nominated for Vice President without any undue pressure and was welcomed on-board. A bonus was that he has a finance background and responded to my call to review our financial processes. He has also introduced Credit Card payments and has streamlined and to some degree "automated" our financial reporting such that our incoming Treasurer will have a model to work from. Finally, Margaret and Garth, both of whom have stood down from the committee after several years of responsibility and hard work. Doubtless they will be available for help and advice if needed.

My heartfelt thanks go to them all for their teamwork and hard work.

We also have a strong team of volunteers that take on key roles. We have the Tea Committee comprising **Caye Higgs** and **John Malone**, ably led by **Dawn Saunders**. They do a wonderful job keeping us fed and watered each month. The irrepressible **Jim Judge**, our Raffle Raconteur and revenue source and his lovely assistant, **Judy Davey**. Our regular "meet and greet" team of **Pat Cox**, **Anne Juster** and **Greg Griffiths**. In the literary area we have Joan **Gai, Convenor** of the Book Club. And finally **Ian Adair**, who sets up the Audio Visual equipment for our Speakers and writes an article on each presentation for the Newsletter.

On the Activities front we've had a range of interesting things to do. Several Town Hall concerts, not oversubscribed by any means, rather attended by loyal few, Opal outings ranging from a trip on the Metro to Tallawong (near Rouse Hill) and a day trip for fish and chips or a curry to Kiama. The Welsh Choir was back in town and some members went to Melbourne for a Flower and Garden Show. Christmas in July was celebrated at Abercrombie House in Bathurst while High Tea was enjoyed at The Carrington. Many attended the resurrected Sausage Sizzle at Abbotsford while an absence of prawns somewhat diminished the enjoyment of the Seafood BBQ. We had the educational visits to the Art Gallery and the State Library while a Show Bag collecting expedition to the Reserve Bank did not meet expectations. The presentation was excellent though. The usual lunches, Birthday, President's and Christmas were enjoyed by many. Many thanks to **Barbara** and her able assistants.

Our speaker list was just as varied. A talk by Susi Prescott who spent some of her life with children in the slums of Arequipa, Chile: a talk on ikebana and bonsai: a local talk about the Hunters Hill Theatre origins: an amazing talk about experiencing without seeing from Nick Gleeson. Ray McLintock told us about Sydney's living museums while Clive Small spoke about the dark side of crime. We then heard about the history of Honeysuckle Creek and its role in the Lunar space program. We had a trombone history lesson and demonstration before a family filmmaking affair with Richard Snashall, son of Norbert. Then we were off to almost the top of Everest with George Mallory before coming back down to earth to hear why the Parthenon Marbles should be returned. All in all an amazingly varied range of topics. Well done **Carol.**

We finished the year in a reasonable financial position as you just heard from Jim. We were successful in lowering some costs and have quarantined some funds for our 50th Anniversary in 2026.

So what else? During my term we averaged 99 members for the period and had an average monthly attendance of 70, with apologies accounting for a further 16. The other 13 were "no-shows". We had 5 resignations primarily due to health and family reasons and welcomed 7 new members. We currently have 96 active and 7 non-active members. We conducted a Members survey and several of the suggestions as they relate to Activities have been adopted, for example the regular coffee morning at Huntleys Cove and an increase in multi-night trips.. Some modifications to the meeting process may also be introduced soon. We've introduced a Policy Register which aims at streamlining many of the processes involved in the running of the Club and implemented changes to the Standing Orders to achieve the same goal. Following the sad passing of Alan James in Canberra, and with the help of Glenys, we have retrieved all his files, created a Membership database and brought the record keeping and reporting back in-house.

Finally, before you all nod off, I must express my thanks to **Mike Regnis**. My strengths do not include an in-depth knowledge of protocols and procedures and so on as they apply to Probus. Thankfully, on a number of occasions, Mike offered advice as to the correct process and methodology and I thank him for that.

Next year, I'll continue on the Committee as Immediate Past President and Newsletter Editor but warn you in advance, I'll not be Editor forever.

Thank you all for the opportunity to serve as your President and I wish Jim and his team ongoing good health, happiness, friendship, fun and fellowship.
