Return Our Marbles

Jim Likidis introduced Emanuel Comino AM, vice chairman of the International Association for the Reunification of the Parthenon Marbles, which he founded in 1998.

Emanuel's talk was entitled The Greek Marbles and Why They Should be Returned.

The story of the Greek Marbles goes back to

hetween 1801 and 1812, when Thomas Bruce, Earl of Elgin, removed а group of classical marble sculp-

tures, or friezes, from the Temple of the Parthenon in Greece and transported them to Britain. Bruce claimed to have received an official decree authorising removal of the friezes from the Ottoman Empire which ruled Greece at the time; this decree has never been found.

The acquisition of the marbles, as they were called, was supported by some, although others, including Lord Byron, called it vandalism and looting. Following a debate in parliament and Elgin's exoneration, he sold the marbles to the British government. They were then passed to the British Museum.

After gaining independence from the Ottoman empire in 1832, the Greek government began a

campaign to retrieve looted art; efforts to repatriate the marbles were maintained and intensified in the 1980s by the then Greek minister of culture, Melina Mercouri.

In 2014 UNESCO offered to mediate between the Greek and UK governments to resolve the dispute, although this was later turned down by the British Museum.

> Various arguments have been put for and against the return οf the marbles. The for case in-

cludes the contention that the marbles may have been obtained illegally, plus the fact that the friezes are part of a single work of art and should be kept together.

Arguments against include the assertion that fulfilling all restitution claims would empty most of the world's great museums. and many more people see the marbles at the British Museum than would see them at the Acropolis Museum in Greece.

Emanuel's talk excited great interest, with suggestions that now Britain has left the EU, this might be the right time to return the marbles to their rightful home.
